Purpose of the hearing is to hear representation regarding the Town of Morris Special Service Proposal Plan No. 2017-01 for the Collection of Garbage and Recyclables and Operations of a Joint Landfill Site within the Town of Morris, pursuant to Subsection 314 of the Municipal Act.

Mayor Gavin van der Linde calls the hearing to order at 7:00 pm. Mayor Gavin van der Linde presents the Special Service Proposal and provides a brief description.

Members in attendance with questions and concerns were then voiced during the presentation.

The following members were heard:

Terence Holding inquired as to how the contact from garbage and recycling was tendered, what is exactly included in the contract, the length of the contract, how everything is collected and the costs incurred. Would also like to know how information on the new collection process and rates were made available to the residents.

Mayor Gavin van der Linde explained the tendering process and what is included in the contact and how those costs are incurred. Also detailed how the information is made available to the public. Councillor Bruce Third also commented that the Town worked closely with MMSM during the tendering process.

John Andrusyk would like to know why the Town is composting.

Councillor Kevin Clace explained the financial and environmental reasons behind the decision to make composting carts available. Mayor Gavin van der Linde explained that diversion from the landfill is important.
